



Insure Your PTA

And Ensure the Success of Your PTA Program!

General Liability Coverage INCLUDES \$25,000 Bond: Has a child cut open an eyebrow in a bounce house at your fall festival or broken an arm at your roller skating party? What would you do if your PTA was sued because of an injury that happened at one of your PTA events? The General Liability policy protects local PTA members and volunteers against lawsuits arising from these types of activities. The policy limits are \$1,000,000 or \$2,000,000 with no deductible.

Bond Coverage (Commercial Crime & Fidelity) \$25,000 included in GL: What do you do when you discover \$20,000 of your fund raising money has been embezzled or stolen? The Bond Insurance will replace your missing funds and avoid having you turned over to a collection agency. The bond limits are **\$25,000(included in the General Liability)** \$50,000 with a \$250 deductible.

Accident Medical (Medical Coverage) Optional: The Accident Medical policy is designed to compliment your General Liability policy. This policy provides medical expense coverage for activities that are excluded from the General Liability policy such as automobiles, mechanical rides, watercraft, and fireworks coverage and provides additional medical payment coverage to help deter lawsuits. **This is not a replacement of your liability policy!** The Accident Medical limits are \$10,000, \$25,000, and \$50,000 with no deductible.

Property Coverage (Business Personal Property) Optional: Raffle merchandise, auction items, fund raising merchandise, school store supplies, and other PTA property would be financially difficult to replace if they were damaged or stolen. The Property Insurance will replace PTA property damaged or lost due to theft or natural hazard. The policy limit is \$10,000 with a \$250 deductible.

Officers Liability (Non-Profit Professional Liability) Optional: As an officer, you could be strapped with huge legal bills because someone has accused you of misrepresenting or mismanaging the PTA. The Officers Liability will provide protection from situations like these. The policy limit is \$1,000,000 with a \$1,500 deductible.
